# **GENERAL CARE**

The holy grail of outdoor furniture manufacturing is finding those mystical materials that neither weather nor fade under the extreme conditions of the great Australian outdoors. At Tait, we will not rest in our quest to find them, but in the meantime, we will keep on using the most premium materials we have at our disposal and tell you how to keep them at their best.

Here at Tait, our purpose is simple. To make beautiful outdoor furniture that's designed to last - at least - a lifetime. Our craft is combining high-performance materials, robust and durable enough to withstand the diverse Australian elements, with timeless, cutting-edge design in order to elevate the outdoor experience.

Put simply, Tait is where handmade, high-end design meets down-to-earth performance

Like owning a luxury car, some TLC on your part will keep your Tait pieces ship shape, allowing them to weather and age gracefully over the seasons. The frequency of maintenance will vary depending on your personal standards and requirements as well as the environment in which the products live.

Careless handling, treatment or misuse of our products can result in damage and is not covered under our manufacturer's warranty. Please refer to the materials and finishes relevant to your product as outlined.

#### **EXCLUSIONS**

The warranty does not cover damage from mishandling, misuse, physical or chemical abuse, by not following proper care and maintenance instructions, accidental damage, damage from chipping, cracking, impact damage or breaking due to customer abuse.

- The warranty does not cover fading or natural ageing of the timber, non-structural defects in the timber, naturally occurring timber features, surface and end checking, or lack of maintenance leading to an acceleration of any of these issues.
- The warranty does not cover corrosion originating from scratches or abrasions that result from general wear and tear and which cannot be removed via standard cleaning and maintenance processes
- The warranty does not cover any occurrence of any detritus, organic or man-made matter settling on the product surface. The warranty excludes buildup of mineral deposits leaching from soils and fertilisers, should it occur on Tait's planters. Nor does this warranty cover any product corrosion directly caused by aforementioned matter.
- The warranty does not cover minor corrosion spots at the weld joins: under table tops, bases and seat frames. These do not affect the structural integrity of the product and are a natural outcome of the material used.
- · The warranty does not cover the corrosion of steel furniture and parts, including stainless steel, as a result of direct use in harsh seafront locations or in a confined, chlorinated environment.
- · The warranty does not apply to normal wear and tear or natural fading of the materials used.
- · The warranty does not apply to any variances in colour, shade or gloss level of finishes, stone tops and timbers.
- The warranty does not cover products that the customer decides they do not like following delivery, including to colour, fabric, timber or other opinions based on personal preference.
- Tait shall not be liable for, and specifically excludes, any claims caused directly or indirectly by any event or matter beyond its control, including incidental, consequential or contingent damages suffered as a result of the use of the furniture or a breach of this warranty either written or implied.
- $\cdot$  All products purchased at a sale price are subject to the specific warranty conditions outlined on sale invoice
- · The warranty does not cover transportation costs for replacement parts and products or labour costs for repair. These costs may be charged at our discretion.
- The warranty does not cover goods which have been held in storage for any period. This is due to the potential impact of environmental extremities which may be present within certain storage facilities.

<u>Please note:</u> Tait cannot provide product refurbishment requests or non-urgent warranties during the period of October 1st - January 30th.

# CARE & MAINTENANCE

Wash regularly with warm soapy water and mild detergent using a soft cloth. For commercial, industrial or marine environments we recommend monthly maintenance. Always rinse well with water, to remove any remaining detergent.

Avoid steam cleaning, pressure washing, abrasive cleansers, steel brushes/wools and cleaners containing chlorine. Avoid scratching the surface by dry dusting. Never use strong solvents to clean powder coated surfaces. Aggressive solvents such as turpentine, white spirits, thinners, citrus based cleaners, Spray and Wipe, and other aggressive solvents are harmful to the extended life of the powder coated surface. Dull surfaces can be revived using a cream cleanser or car polish. Do not allow detritus, organic or man-made matter to settle on the product surface. We recommend removing any buildup of mineral deposits leaching from soils and fertilisers, should it occur on Tait's planters.

Rough treatment of powder-coated furniture can result in chipping of the coated surface; this is not covered under warranty.

Most Tait products come with protective fittings - stacking glides, bumpers, socks/feet and glides. These aid in protection against chipping and scratching. Powder coated stacking chairs are



designed to be set in place gently.

Touch-up paint may be purchased on request. It is advisable to repair minor nicks and scratches as soon as they appear.

When placing a furniture cover over a table for an extended period of time, it is recommended to first place an empty plastic pot plant in the centre of the table, then placing the furniture cover over the top. This will prevent the possibility of the furniture cover adhering to the table surface.

Should you wish to touch up any blemishes which may occur, please contact your nearest Tait showroom and request a Powder Coat Touch Up Kit. Please follow our Powder Coat Touch Up Guide (available under 'Dimensions and Specs - Download Assets' on the product page) for application details.

#### WARRANTY

Powder coat is a decorative finish for indoor and outdoor use. While it assists with metal protection, it is not a corrosion protection in its own right. The components of Tait powder coated products are produced in either aluminium, stainless steel or mild steel.

The mild steel base materials are treated with two levels of pre-protection that guard against corrosion. The products are then powder coated to make the surface resistant to corrosion and suitable for use in exterior environments.

Minor corrosion spots at the weld joins - under table tops, bases and seat frames, may be evident on mild steel products. These do not affect the structural integrity of the product and are not covered by the Tait warranty.

Whilst every care is taken to provide the most suitable finish according to the use and the environment the product will be subjected to, Tait cannot guarantee this decorative finish against scratching, scuffing, chipping, fading or corrosion as a result of use in harsh seafront, extreme or environments where chlorine is present.

Tait offer a range of powder coat colours which offer excellent UV stability and are suitable for use in outdoor applications. Whilst powder coat offers excellent colour retention, natural fading is not covered under the Tait warranty. To ensure longevity of this finish please refer to the care and maintenance.

The warranty does not cover any occurrence of detritus, organic or man-made matter settling on the product surface. The warranty also excludes buildup of mineral deposits leaching from soils and fertilisers, should it occur on the surface of Tail's planters. Nor does this warranty cover any product corrosion directly caused by aforementioned matter.

Tait assume no responsibility for product damage caused by the use of furniture covers.

# FABRIC

## CARE & MAINTENANCE

As a leading manufacturer of outdoor design built to withstand harsh elements, we take pride in helping you get the most out of your Tait pieces. Much like owning a luxury tailored suit or dress, we recommend some key measures to ensure your fabric upholstery maintains its high-performance and good looks for many years to come.

Tait recommends a select range of premium, high-performance, exterior-grade upholstery options, these fit-for-purpose fabrics have been hand-picked from a number of trusted textile suppliers world-wide. Constructed with the highest quality man-made yarns suited to outdoor extremities, these fabrics are advantageous for their inherent stain-resistance, colour-fast resilience and durable qualities. In addition, many of these fabrics feature advanced technologies in their construction including solution-dyed olefin and acrylic, as well as Trevira CS flame retardance. Tait's range of selected fabrics have been used extensively and have performed exceptionally across numerous commercial and residential projects worldwide. Due to their ability to perform and cope under demanding pressures this selection of fabrics form Tait's tried and trusted range.

While individual fabrics will each have their own set of care and maintenance requirements as outlined by the supplier, the following provides general information to assist you in best-care for your upholstered items.

# RECOMMENDATIONS

- Where upholstery products are continually exposed to the elements (uncovered location), it's highly recommended to keep upholstered seating protected where possible or to store any seat cushions when not in use. This will lengthen the life of your upholstery.
- When not in use, we recommend storing upholstery in sheltered places and/or covering it with waterproof protection. In this case, it is advisable to remove the cover and ventilate the product regularly to avoid the onset of any stains due to damp.
- When constantly exposed to the elements (including pollutants such as dirt, abradants etc) outdoor fabrics will begin to degrade without care and maintenance. Just as timber and metal materials are affected by weathering, as too are fabrics.
- As with indoor materials, it is also essential that fabrics are vacuumed and cleaned regularly. Detritus; including
  food, bird or bat excrement, seeds, fruits, flowers from overhanging vegetation, can all have lasting impact on
  fabrics. We recommend removing these from the fabric surfaces as soon as possible to ensure the fabric looks
  its best for as long as possible.



- Organic matter specifically contains natural chemicals and acids, these will not only affect textiles, but also other materials including timber, paint and concrete.
- To prolong the life of the product, clean surfaces regularly and dry them with a clean cloth.
- Remove any stagnant water, especially if exposed in locations with a high level of humidity or a marine climate.
- It is always recommended to scrape any stains or spills off the surface of the fabric and carefully spot clean with soapy water. Make sure it is rinsed well with clean water afterwards to remove any remaining soap.
- Many outdoor fibres are so resilient that we even recommend cleaning with diluted bleach solution for very stubborn stains and marks. Please always check care details with the fabric supplier prior to using a bleach solution on the fabric.

#### DO NOT

- Remove covers or machine-wash any upholstered items, as this may result in fabric shrinkage and foam distortion.
- Store away or cover upholstered items that are damp or wet, as this may result in mould or mildew forming. Ensure upholstery is completely dry before storing or covering.
- Dry clean or steam clean outdoor fabrics.

#### VOLLEY ROPE

This is a high strength, UV-stable polyester rope. To clean it, use a damp cloth with a solution of warm water and mild soap, then rinse with another damp cloth with water only. Allow to air dry. If the stain is deep or dirt persists, re-wet the rope with soap and water and rub with a soft plastic bristle brush. Rinse and let dry.

#### WARRANTY

- Fabrics, even if intended for outdoor use, may still be attacked over time by atmospheric pollutants. Any changes in the surface and in colours may therefore occur under particular conditions of exposure to said pollutants and cannot be considered grounds for a warranty claim.
- Outdoor fabrics are lined unglued, therefore any creasing in the upholstery is an inevitable consequence of use and cannot be considered grounds for a warranty claim.
- All fabrics used by Tait are bound by the fabric supplier's own warranty. Please refer to individual fabric suppliers for detailed information on care and maintenance.
- The warranty is extended to the invoiced purchaser only. Any claims must be by the invoiced purchaser.
- Tait provides no warranty direct or indirect, implied or referred.
- The application of third party fabric treatments will void upholstery warranty.
- Tait offers a 1-year warranty on upholstery components, this includes foam and finishing (stitches, zips etc).
- Optional furniture covers purchased are not included in Tait's warranty and are bound by the individual furniture cover supplier.

THIS WARRANTY WILL NOT COVER DEFECTS OR IMPERFECTIONS RESULTING FROM THE PASSAGE OF TIME OR DUE TO WEAR AND TEAR INCURRED BY NORMAL USE OF THE PRODUCT.

# SUSTAINABLE TIMBER

# CARE & MAINTENANCE

Tait select premium Accoya Timber and Smoked Oak engineered timbers that provide superior rot-resistance, defy the elements and stay strong for decades and are manufactured using clean technologies and sustainably sourced.

Accoya® Timber is modified by acetylation. Acetylation is a non-toxic process in which radiata pine is soaked in an organic compound related to vinegar, making the wood more resistant to moisture, insects, and rot.

Smoked Oak is thermally modified timber. Thermally modified timber is heated using a totally 'green' chemical-free process to permanently change its properties. Essentially, the timber stops absorbing water and becomes a stable, durable product that resists shrinkage, swelling, decay, rot, mould and insect attack.



Tail's Accoya® and Smoked Oak timber products are coated with the Teknos® water-based Coating System which has been specially formulated for use on high-performance timbers and further assists in protecting the timber from mould, fungus and green algae.

The Teknos® Coating System includes a factory-applied, water-based primer which provides an initial layer of weatherproof protection. The timber is then finished with a water-based topcoat which is available in either a natural/clear finish or a range of translucent tinted colours.

The Teknos® Coating System provides the best level of trans-seasonal UV and moisture protection for your outdoor furniture short of an actual cover.

To comply with warranty requirements, cleaning and maintenance of timbers are obligatory. Please ensure you can prove that care and maintenance has been performed as described below.

#### Every 3 - 6 months

Depending on finish and exposure, inspect the coated timber for signs of colour loss, dryness and weathering. Re-coat the timber when it begins to show signs of dryness, this helps to maintain its natural beauty and to protect the surface.

DO NOT sand the timber

#### Every 6 - 12 months

Surface clean the wooden elements of your outdoor furniture pieces at least twice a year. Wash the surfaces thoroughly with clean water to remove dust, grime and insects. A build-up of dust and grime can lead to the increased growth of green algae and other surface fouling.

#### Recoating your timber

To restore the original appearance of timber please contact your nearest Tait showroom to request a maintenance kit and follow the Teknos Finish Reapplication Guide (under "Dimension Specs - Download Assets" on the product page).

When placing a furniture cover over any table for an extended period of time, it is recommended to first place an empty plastic pot plant in the centre of the table, then placing the furniture cover over the top. This will prevent the possibility of the furniture cover adhering to the table surface.

Careless handling, treatment or misuse of our products can result in damage and is not covered under our manufacturer's warranty.

#### WARRANTY

Accoya® timber is perfect for exterior furniture applications. The Accoya® timber component is covered for 1 year from the date of purchase, subject to proper maintenance by the purchaser and fair wear and tear. Accoya timber is treated Radiata Pine, is a softwood therefore subject to denting.

Smoked Oak is a thermally modified timber. The Smoked Oak timber component is covered for 1 year from the date of purchase, subject to proper maintenance by the purchaser and fair wear and tear.

End and surface checking may appear and is not claimable under warranty.

Any changes in the visual appearance of timber that are directly linked to ageing are not covered by warranty. As timber is a living material, the appearance of its surface evolves naturally over time.

Tait recommends regular maintenance with Teknos coating to reduce colour loss, dryness and weathering. Engineered timbers that have been treated with tinted Teknos coating may fade when placed in direct sunlight. This is not covered by the Tait warranty.

Tait assume no responsibility for product damage caused by the use of furniture covers.

# **GLASS**

# CARE & MAINTENANCE

Please Note: Tait's glass option was discontinued from all Tait products on 1.6.2020. Please see recommendations below should you own an existing Tait product with glass table top.

Although our laminated glass [AS4669] is much more durable than normal glass, it is not unbreakable and should be treated with the same care as normal glass.

## DO

- Remove spills and stains with warm water, mild soap solution and a soft non-abrasive cloth
- -Polish using either plain water and a micro-fibre cloth or a commercial glass cleaner

## DO NOT

- Sit or stand on the glass (yes, it needs to be said)



- -Drop objects onto the glass
- -Drag sharp or coarse objects across the glass top
- -Drag your glass-topped table

Careless handling, treatment or misuse of our products can result in damage and is not covered under our manufacturer's warranty.

## WARRANTY

Tait glass-topped tables use laminated glass, suitable for furniture applications as per the Australian Standard 4669. Glass is not guaranteed against scratching and chipping and this is not covered by the Tait warranty.
